ARTICLES OF INCORPORATION OF CONQUEST SERVICES, INC.

Article I - Name

Effective Date

The name of this corporation is CONQUEST SERVICES, INC.

Article II - Duration

This corporation shall have perpetual existence, commencing on OCTOBER 01, 2007.

Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article IV - Capital Stock

This corporation is authorized to issue $\underline{1,000}$ shares of common stock, with par value of \$\frac{1.00}{0}\$ which shall be designated "Common Shares."
