## ARTICLE 5 - CORPORATE CAPITALIZATION

- 5.1 The maximum numbers of shares that this Corporation is authorized to have outstanding At any time are ONE THOUSANDS (1000) stocks, each share having the par value of ONE DOLLARS (\$1.00) each.
