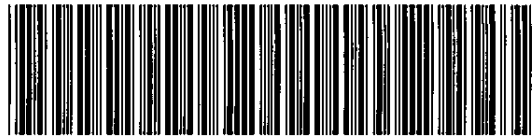



ARTICLES OF INCORPORATION
OF

The undersigned, acting as the incorporator of INSURED'S PUBLIC ACTION COALITION, INC., a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation.

ARTICLE I - NAME

The name of this corporation is INSURED'S PUBLIC ACTION COALITION, INC.

ARTICLE II - ADDRESS

The principal office of the Corporation shall be 1660 North Maitland Avenue, Maitland, Florida 32751.

ARTICLE III - CORPORATE EXISTENCE

The Corporation will exist commencing on the date of filing these Articles of Incorporation with the Florida Department of State.

ARTICLE IV - DURATION

The corporation shall have perpetual existence.


ARTICLE XI - BYLAWS
