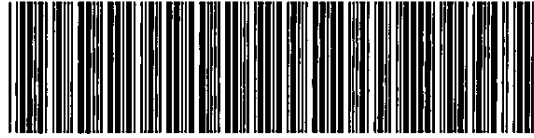

Amendments

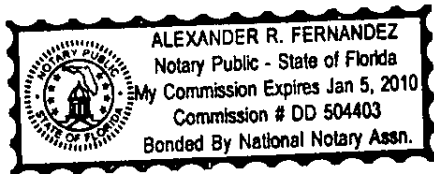


