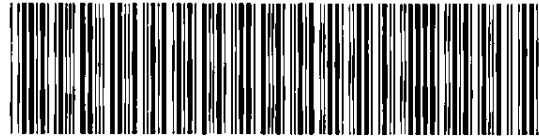

ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION, AS AMENDED OF  
GREEN DRAGON WOOD PRODUCTS, INC.

Pursuant to Section 607.1006 of the Florida Business Corporation Act of the State of Florida (the "FBCA"), the undersigned Chief Executive Officer of Green Dragon Wood Products, Inc. (the "Corporation"), a corporation organized and existing under and by virtue of the laws of the State of Florida, does hereby certify:

FIRST:

The Board of Directors approved the following amendment to the Corporation's Amended and Restated Articles of Incorporation by a unanimous written consent on February 10, 2017 pursuant to Section 607.0821 of the FBCA, and recommended that the Corporation's shareholders approve such amendment.

SECOND:

The holders of a majority of the Corporation's issued and outstanding voting stock, representing all of the voting securities of the Corporation, approved the following amendment to the Corporation's Articles of Incorporation, as Amended by written consent on February 22, 2017 pursuant to Section 607.0704 of the FBCA.
