



### ARTICLES OF INCORPORATION OF

PURDLE CREEK COMPANY, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby associate themselves to form a corporation under the laws of the State of Florida.

ARTICLE I.

NAME

The name of this corporation is:

#### PURDLE CREEK COMPANY, INC.

#### ARTICLE II.

#### NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

To engage in every lawful activity permitted under Florida laws and particularly the following activities which are stated for explanation rather than qualification or limitation.

To conduct business in, have one or more offices in, and buy hold, mortgage, sell, convey, lease, or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks, and licenses in the State of Florida and in all other states and countries.

To contract debts and borrow money, issue and sell of pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property or other instruments to secure the payments of corporate indebtedness as required.

To purchase the corporate assets of any other corporation and engage in the same or other character of business.

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities or other evidence of indebtedness created by any other corporation of the State of Florida or any other state or government, and while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.

To manufacture, purchase, or otherwise acquire, and to own mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property, and service of every class, kind and description; except that it is not to conduct a banking, safe deposit, trust, insurance surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.

#### ARTICLE III.

#### CAPTIAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is:

One Thousand (1,000) shares

of no-par common stock.

#### ARTICLE IV.

#### INITIAL CAPITAL

The amount of capital with which this Corporation will begin business is not less than the amount required by law.

#### ARTICLE V.

This corporation is to exist perpetually.

#### RESTRICTIONS ON RIGHT TO TRANSFER STOCK

#### ARTICLE XI.

- No contract or other transactions between the corporation and any other firm, association or corporation shall be affected or invalidated by the fact that any one or more of the Stockholders of the corporation is or are interested in or is a member, director, or officer or are members, directors or officers of such other firm or corporation or any director or directors individually interested in any contract or transaction of the corporation or in which the corporation is interested; and no contract, act or transaction of the corporation with any person, firm, association or corporation shall be affected or invalidated by the fact that any stockholder or stockholders of the corporation is a party or are parties to or interested in such contract, act or transaction or in any way connected with such person, firm, association or corporation and each and every person who may become a stockholder of the corporation is hereby relieved from any liability that might otherwise exist from contracting with the corporation for the benefit of himself or any firm, association or corporation in which he may in any way be interested.
