

The undersigned subscriber to these Articles of Incorporation is a natural person, competent to contract, and hereby forms a Corporation for profit under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of the Corporation shall be TerraQuest of Pinellas, Inc.

**ARTICLE II - NATURE OF BUSINESS**

The purpose of this Corporation is to engage in every aspect of operating as a real estate holding company and to engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

**ARTICLE III - CAPITAL STOCK**



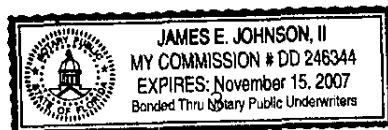


