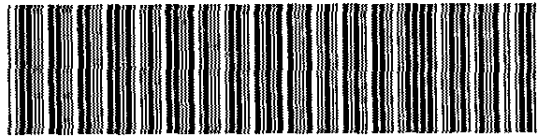

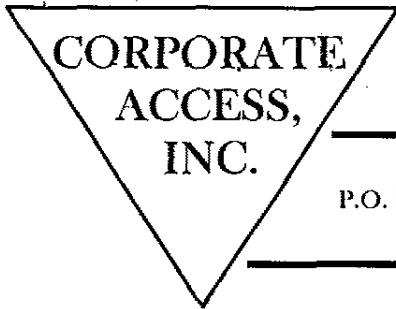

Article 1 - Name and Address

The total authorized capital stock of this Corporation shall consist of One Thousand (1,000) shares of common stock having no par value.

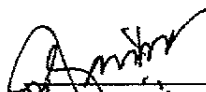

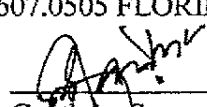
Article 6 - Initial Registered Office and Agent
