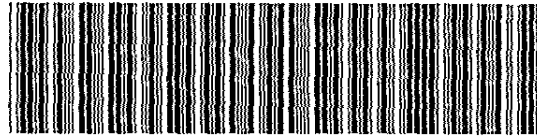

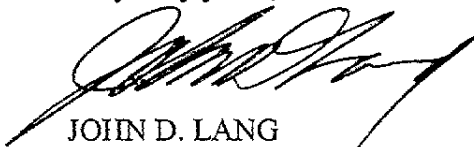

This corporation is authorized to issue only one class of shares of stock; and, the total number of shares which this corporation is authorized to issue is ten thousand (10,000), no par value.

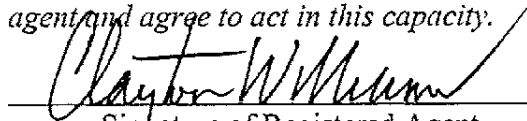

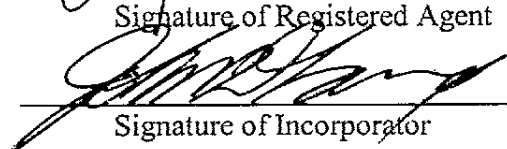
