

Articles of Amendment to

Articles of Incorporation of

MADISON COMMUNITY BANCSHARES CORPORATION

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida Profit
Corporation adopts the following amendment to its Articles of Incorporation:

AMENDMENT

ARTICLE III is amended as follows:

The total number of shares authorized to be issued by the Corporation shall be Four Million (4,000,000) shares. Such shares shall be of three classes. The total number of common shares authorized to be issued by the Corporation shall be Two Million (2,000,000) shares and shall have a par value of \$5.00 per share. The total number of non-voting, non-cumulative preferred shares authorized to be issued by the Corporation shall be One Million (1,000,000) shares, and shall have a par value of \$10.00 per share. The total number of non-voting cumulative preferred shares authorized to be issued by the Corporation shall be One Million (1,000,000) shares, and shall have a par value of \$10.00 per share.

ADOPTION OF AMENDMENTS

The date of this amendment adoption is April 18, 2011

The amendment was adopted by the board of directors and shareholders by a super majority. The number of votes cast for the amendment by the board of directors were 13 aye and 0 nay votes. The number of votes cast for the amendment by the shareholders were 450,548 aye and 0 nay votes.
