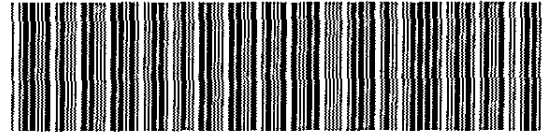

**ARTICLES OF INCORPORATION
OF

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**

The name of this corporation is CARPENTER DAVE'S CONSTRUCTION COMPANY.

**ARTICLE II
PRINCIPAL OFFICE/MAILING ADDRESS**

**ARTICLE III
SHARES**

The number of shares the corporation is authorized to issue is 1000 shares par value of \$1.00 per share.

**ARTICLE IV
PREEMPTIVE RIGHTS**

This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
