## ARTICLES OF INCOPORATION OF K & J COMPASSIONATE CARE INC.

I, the undersigned incorporator of this corporation under chapter 607, Florida status, a amended, adopt the following Articles of Incorporation:

#### ARTICLE I-NAME

The name of the corporation is:
