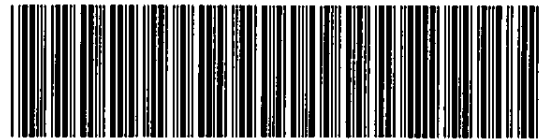

**ARTICLE VII - INITIAL BOARD OF DIRECTORS**


