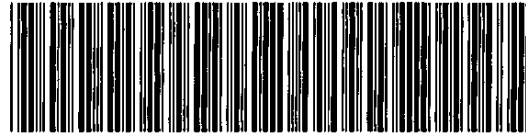

The undersigned, for the purpose of forming a nonprofit corporation under the Florida Not for Profit Corporation Act, Florida Statutes Chapter 617, makes and adopts the following articles of incorporation:

**ARTICLE-1 Name**

The name of the corporation is as follows:

**ARTICLE-3 Purposes**

Care America, Inc is organized and shall be operated exclusively for charitable, educational, and scientific purposes. The primary purpose of the organization is to extend high quality social economic development services and assistance to improve and strengthen the well-being of the underserved individuals and communities. This includes but not limited to providing training and technical assistance to communities and community groups that support and nurture economic and social development, capacity building, sustainability, and natural resources endurance and growth. The ultimate goal of the Corporation is to improve the quality of life for the people and the communities.

To help further its purpose of existence, the organization shall, in addition to training and education; organize, collaborate and coordinate preparation and professional development activities such as relief and long-term recovery by working with and through elected leadership, governmental agencies, institutes of learning, private businesses, and other community-based, faith, and Non-Governmental Organizations (NGO).

#### **ARTICLE-4 Board of Directors**

There shall be a Board of Directors consisting of at least three individuals. The initial directors are elected by the incorporator. After that, each director shall be elected by the majority vote of the Board of Directors in the manner and at the times set forth in the bylaws. Any director may be removed by the affirmative vote of at least two thirds of the Boards of Directors.

#### **ARTICLE-5 Powers**

Solely for the above purposes, the corporation shall have the following powers:

A. To exercise all rights and powers confer by the Laws of the State of Florida non profit corporation, including but not limited to those set forth in Florida Statutes Chapter 617 and the following powers: To acquire by bequest, devise, gift, grant, donation, contribution, purchase, lease or otherwise any property of any sort or nature without limitation as to its amount or value, and to hold, invest, reinvest, manage, use, apply, employ, sale, expend, disburse, lease, mortgage, convey, option, donate or otherwise dispose of the property and the income, principal and proceeds of the property.

B. To engage in and transact any other lawful activity, solely in furtherance of the above purposes, for which non-profit corporation may be incorporated under the Florida Not For Profit Corporation Act., and any other successor or amendment to the Florida Not For Profit Corporation Act.

C. To do any other things as are in incidental to the powers of the corporation or necessary or desirable in order to accomplish the purposes of the corporation
