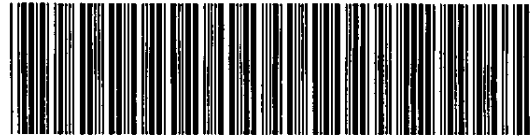

The current Officer and Director of the Corporation is Pamela Lomba, who shall serve as sole Director and also as acting President, Secretary and Treasurer of the Corporation.


