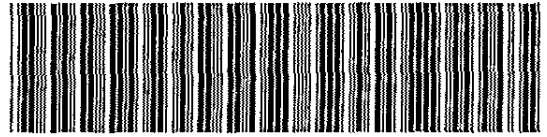

ARTICLE II

This Corporation is authorized to issue 500 shares of \$1.00 par value common stock, which shall be designated as "Common Shares".

ARTICLE IV
