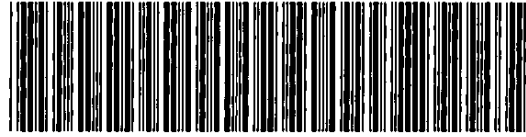

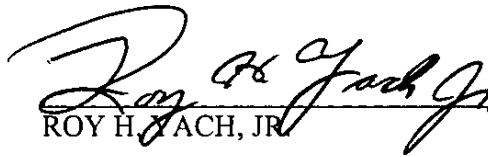
The corporation shall indemnify any officer or director, or any former officer and director, to the full extent permitted by law.

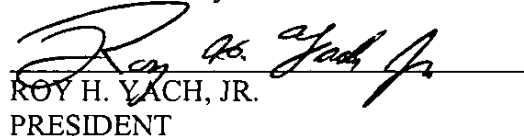

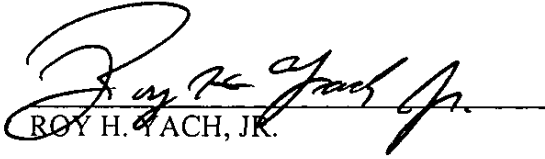
