
FYI, I resigned as President and involvement with Enter Action in January 2009. Therefore, please consider this letter as my formal resignation as President and Financially Responsible Officer of Enter Action, Inc. My resignation is effective as of January 15, 2009. I am no longer associated with this corporation in any capacity. Please provide written confirmation of my removal as President and Financially Responsible Officer of Enter Action, Inc by return mail. "

I am unsure why this couldn't have been used to provide confirmation to me. Delaying this process puts me at financial risk since we already dissolved the company. For your information, Gary Miner, on his own, reversed this dissolution order and without approval from me, as President, deleted my name as President, and he also deleted Martin Lutoy as Secretary and deleted Vladi Petrov as Treasurer. In replacement he appointed Jeff Miner as President. Please remember he did this without discussion or agreement by the shareholders, partners and Board. How is this possible?

As such please provide written confirmation that my name is deleted and withdrawn from all aspects of Enter Action Inc (DBA C5 Construction Services) effective immediately, including being the Financially Responsible person for the company. If this request is not possible, please advise what I need to do to complete this process ASAP. Your attention to this matter would be greatly appreciated.


