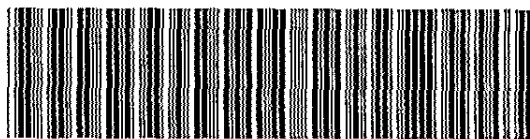

OF

The undersigned incorporator to the Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation shall be **DALLEY ENTERPRISES, INC.**

ARTICLE II. PRINCIPAL OFFICE

The principal office of this corporation shall be located at **208 Highview Avenue** in the City of **Lehigh Acres**, County of **Lee**, State of **Florida**, and the post office address of said principal office of the corporation shall be **P.O. Box 1265, Lehigh Acres, FL 33936**.

ARTICLE III. PURPOSE

The general nature of the business and the objects and purposes proposed to be transacted and carried on are to do any and all of the things herein mentioned, as fully and to the same extent as natural persons might or could do, viz.:

ARTICLE VIII. DURATION
