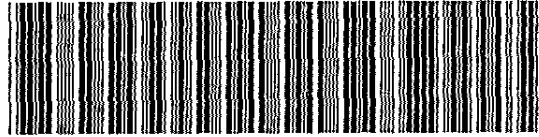

ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED, acting as Incorporator of the PEPITO & PEPINO, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following ARTICLES OF INCORPORATION for such Corporation:
