ARTICLES OF INCORPORATION

OF

CHARLES ANTHONY DEVELOPMENT INSTITUTE, INC.

The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I: NAME OF THE CORPORATION

The name of the corporation is CHARLES ANTHONY DEVELOPMENT INSTITUTE, INC. hereinafter referred to as the "Corporation".

ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

The mailing address and the principal office of the corporation is 14036 S.W. 90<sup>th</sup> AVENUE, #AA203, MIAMI, FLORIDA 33176.

ARTICLE III: DURATION OF THE CORPORATION

The period of duration of the Corporation shall be perpetual unless dissolved according to law.
