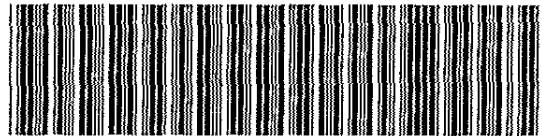



**ARTICLES OF INCORPORATION
OF
ARCHIE'S INTERIOR DESIGN, INC.
a Florida Corporation**

The undersigned, acting as Incorporator for this Florida corporation hereby incorporated under the Florida General Corporation Act, Chapter 607 of the Florida Statutes, and the undersigned hereby adopts the following Articles of Incorporation for this Corporation:

ARTICLE I – CORPORATE NAME & ADDRESS

The name of this Corporation is **ARCHIE'S INTERIOR DESIGN, INC.**, and the mailing address for the principal office of this corporation is 2844 Northwest 4th Lane, Gainesville, Florida, 32607.

ARTICLE II - PURPOSE


