# ARTICLES OF INCORPORATION OF BARRY L. GOULD, P.A.

The undersigned, for the purpose of forming a professional corporation under the provisions of Chapter 621 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:

#### ARTICLE I - NAME AND PRINCIPAL OFFICE

The name of the Corporation shall be BARRY L. GOULD, P.A., a Floridal professional service corporation. The street address of the initial principal office of the Corporation is 6311 Gulf Drive, Holmes Beach, FL 34217, which is also the mailing address of the Corporation.

#### ARTICLE II - PURPOSE AND POWERS

Section 1. The Corporation is formed for the purpose of providing the services of a real estate sales associate as described in Part I of Chapter 475 of the <u>Florida</u> Statutes, and all other activities related thereto.

Section 2. The Corporation may exercise all powers, rights and privileges conferred on professional corporations pursuant to the laws of the State of Florida.

#### ARTICLE III - TERM OF EXISTENCE

The Corporation's term of existence shall commence upon filing these Articles with the Florida Department of State, and shall continue perpetually.

#### ARTICLE IV - CAPITAL STOCK

The authorized capital stock of the Corporation shall be one thousand (1,000) shares of common stock having no par value.

#### ARTICLE V - BOARD OF DIRECTORS

Section 1. The business and affairs of the Corporation shall be managed by a Board of Directors, the members of which shall be hereinafter referred to as Directors.

Section 2. The initial Board of Directors of the Corporation shall consist of two (2) Directors, whose names and addresses are as follows:

Section 3. The number of Directors shall be as provided in the Bylaws of the Corporation, but shall not be less than one (1).

Section 4. Directors shall be elected and hold office as provided in the Bylaws.

### ARTICLE VI - BYLAWS

Section 1. The Board of Directors shall adopt Bylaws for the Corporation at a meeting of the Board of Directors following the filing of these Articles of Incorporation.

Section 2. The power to adopt, alter, amend or repeal the Bylaws of the Corporation may be exercised by the Board of Directors or the Shareholders in accordance with the provisions of the Bylaws.

Section 3. Any Bylaws adopted by the Board of Directors or the Shareholders may be altered, amended or repealed by the other group; provided, however, that any Bylaws adopted by the Shareholders may provide that it shall be altered, amended, or repealed only by the Shareholders.

#### ARTICLE VIL- AMENDMENTS

These Articles of Incorporation may be amended as set forth in the <u>Florida</u>

<u>Statutes</u>, as amended from time to time.

#### ARTICLE VIII - REGISTERED OFFICE AND AGENT

Section 1. The street address of the initial registered office of the Corporation shall be 6311 Gulf Drive, Holmes Beach, FL 34217.

Section 2. The name of the initial registered agent of the Corporation located at said address shall be Barry L. Gould.
