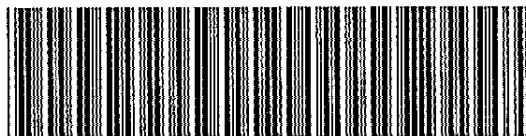

ARTICLES OF INCORPORATION

OF

S. AVERY SMITH, P.A.

CLERK OF THE STATE
TALLAHASSEE, FLORIDA

The undersigned incorporator, S. AVERY SMITH, a natural person competent to contract, and licensed to render services as an attorney at law under the laws of the State of Florida, hereby presents these Articles of Incorporation for the formation of a corporation under the Professional Service Corporation Act and other laws of the State of Florida.

ARTICLE I – NAME

The name of this Corporation is S. AVERY SMITH, P.A.

ARTICLE II – PRINCIPAL OFFICE

The address of the principal office of the corporation is 2859 Willow Bay Terrace, Casselberry, Florida 32707.

ARTICLE III – NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be:

- (a) To engage in every phase and aspect of the business of rendering professional services that an attorney at law duly licensed under the laws of the State of Florida is authorized to render, but such professional services shall be rendered only through officers, employees, and agents who are duly licensed under the laws of the State of Florida to practice law therein.
- (b) To invest the funds of the corporation in real estate, mortgages, stocks, bonds, or any other types of investments, and to own real and personal property necessary for the rendering of professional services.
- (c) To do everything necessary and proper for the accomplishment or furtherance of any of the purposes or the attaining of any of the objectives enumerated in these Articles of Incorporation, or any amendment thereof, necessary or incidental to the protection and benefit of the corporation; and in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes or objectives of the corporation.

The foregoing paragraph shall be construed as enumerating both objectives and purposes of the corporation, and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of the corporation otherwise permitted by law.

ARTICLE IV – SHARES

The aggregate number of shares which the Corporation shall have the authority to issue shall be 1,000 shares of common stock. Each such share shall have a par value of \$1.00 per share. None of the shares of the corporation may be issued to anyone other than an individual duly licensed to practice law in the State of Florida.

ARTICLE V – INITIAL REGISTERED AGENT AND ADDRESS

The address of the initial registered office of this corporation is 2859 Willow Bay Terrace, Casselberry, Florida 32707. The name of the Corporation's initial registered agent to receive service of process is S. Avery Smith.

ARTICLE VI – INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be increased or decreased from time to time by the bylaws, but shall never be less than one (1). The name and address of the initial director of this corporation are:
