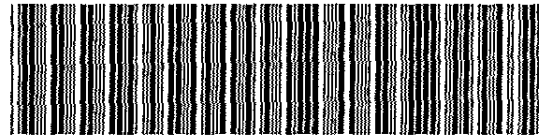



The name of this corporation is **TRINITY ANESTHESIA SERVICE, INC.**
