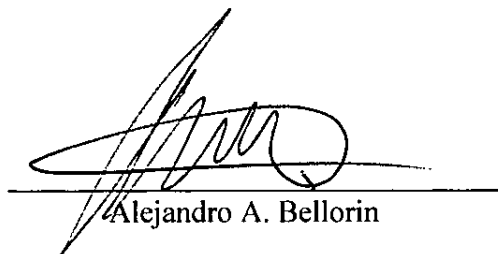
RESOLUTION ADOPTED BY THE INCORPORATORS
