ARTICLES OF INCORPORATION OF

IVU CORPORATION

ARTICLE I-NAME

The name of this Corporation is IVU CORPORATION

ARTICLE II-DURATION

This Corporation shall have a perpetual existence commencing on the Date of Filing.

ARTICLE III-PURPOSE
