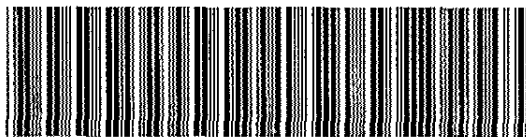

ARTICLES OF INCORPORATION
OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, make this certificate for the purpose of forming a corporation, to be known as ANDERSON INSURANCE & INVESTMENTS COMPANY, for the purpose of becoming such corporation for profit under the laws of the State of Florida for the purpose with the rights, powers and objects hereinafter set forth, as follows:

ARTICLE I

The name of the corporation shall be ANDERSON INSURANCE & INVESTMENTS COMPANY.

ARTICLE II

To engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is 100 shares of non par value stock.

ARTICLE IV

INITIAL CAPITAL

The amount of capital with which this corporation will begin business is FIVE HUNDRED AND NO/100 DOLLARS (\$500.00).
