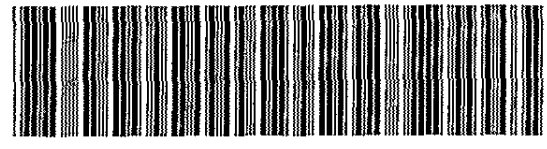


I went to sunbiz.org and filed incorporation paperwork for RNJ FINANCIAL, INCORPORATED.






