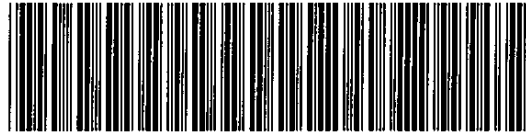

The undersigned, acting as incorporator of Félix M. Cáceres II, P.A., under the Florida Business Corporation Act, and the Professional Service Corporation and Limited Liability Company Act, adopts the following Articles of Incorporation.

**ARTICLE I
NAME**
