<u>ARTICLE I</u>

NAME AND ADDRESS

The name of this corporation is TURN THE PAGE PRODUCTIONS, INC. and its principal address and its mailing address is 4211 Lake Forest Drive, #712, Bonita Springs, Florida 34134.

ARTICLE II

DURATION

This corporation shall exist perpetually commencing on the date of execution of these Articles of Incorporation.

ARTICLE III

PURPOSE

This corporation is organized to engage in the business of video production and preparation of written articles, and for all other purposes allowed a Florida corporation.

CAPITAL STOCK
