ARTICLES OF INCORPORATION

OF

TINT BIZ GLASS PROTECTION & WINDOW TINTING, INC.

The undersigned, acting as incorporator of TINT BIZ GLASS PROTECTION & WINDOW TINTING, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME
