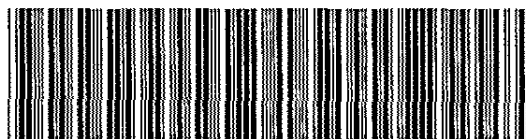


#### **ARTICLE IX**

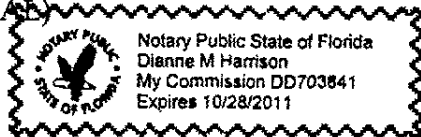


