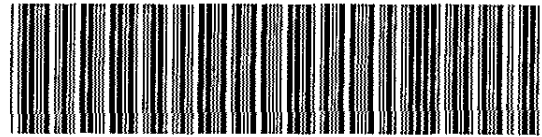

The undersigned, acting as Incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation.

**FIRST:**       The name of the Corporation is:  
                  L & L Communications Services, Inc.

**SECOND:**     The period of duration of the Corporation is perpetual.

**THIRD:**       The general purpose for which this Corporation is organized is as follows:

To transact and engage in any activity or business permitted under the laws of the United States and the State of Florida; except that it is not to conduct banking, safe deposits, or cemetery company, a building and loan association, or other things as are incidental to the foregoing or necessary, or desirable in order to accomplish the foregoing.

**FOURTH:**     Authorized shares:

**Number:**       The aggregate number of shares that the Corporation shall have the authority to issue is 1,000 shares of Capital Stock with par value of \$1.00 per share.

**State Capital:** The sum of the par value of all shares of Capital Stock of the Corporation that have been issued shall be the state Capital of the Corporation, at any particular time.

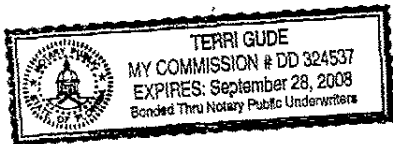

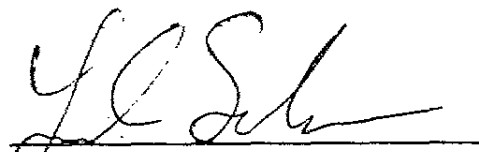
