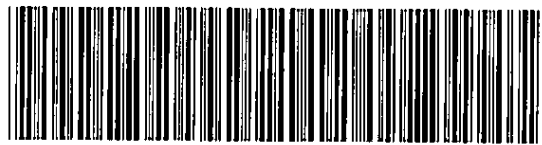

This amendment was made on June 21, 2019 unanimous by vote of the one stockholder of common stock of the corporation. The number of votes cast by the members was sufficient for approval.

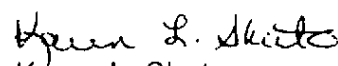
