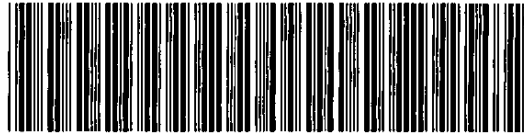

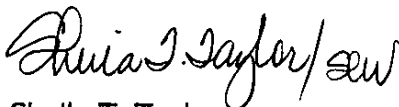

ARTICLE I

The name of this corporation is: **INTERSTATE PAWN, INC.,**

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

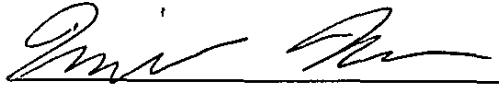
ARTICLE IX - BYLAWS

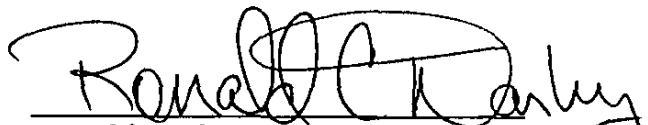
The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors and the shareholders.

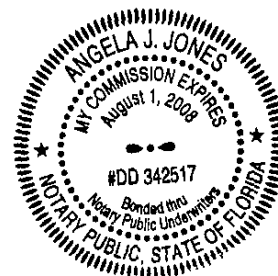

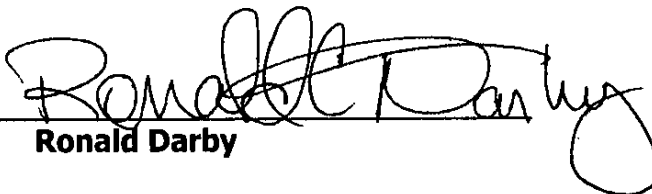

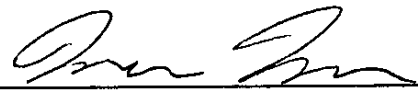
