ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I NAME

The name of the corporation shall LRP Investments, Inc. For convenience, the Corporation shall be referred to in this instrument as the "Corporation".

ARTICLE II PLACE OF BUSINESS
