ARTICLE I: NAME



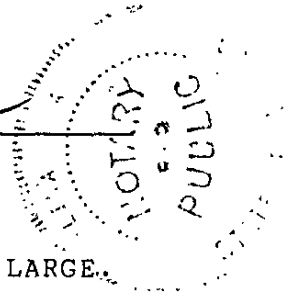

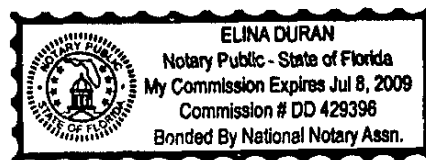
