- 1.1. The name of the corporation is **JPL ADVISORS, INC.**

Indemnification

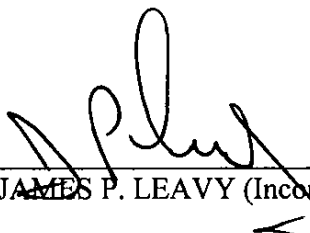

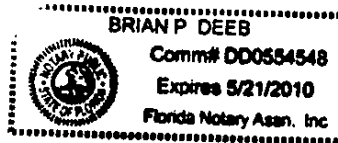

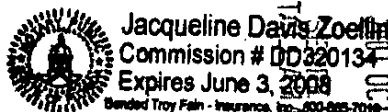
