We, the undersigned subscribers to these Articles of Incorporation, natural persons and competent to contract, hereby form a corporation under the Laws of the State of Florida.

ARTICLE I

Name of Corporation

Nature of Business

The general nature of business to be transacted by this corporation is child care services as well as any other activities or business permitted under the Laws of the United States and the State of Florida.
