ARTICLES OF INCORPORATION

Pursuant to the Florida Business Corporation Act, Chapter 607, <u>Florida Statutes</u>, the undersigned incorporator of Fireline Restoration of California, Inc., a Florida corporation (the "<u>Corporation</u>"), hereby adopts the following Articles of Incorporation for the Corporation:

ARTICLE I NAME AND ADDRESS

ARTICLE II BUSINESS AND ACTIVITIES
