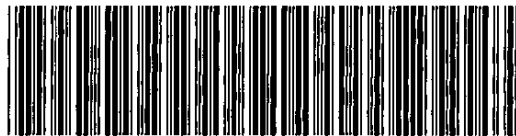

I, the undersigned do hereby form a corporation for the purpose hereinafter stated and do hereby certify as follows:

ARTICLE I - NAME

The name of the corporation shall be and is hereby declared to be LDAVIS TECH SERVICES, INC..

ARTICLE II - PRINCIPAL OFFICE

The principal place of business is 512 Pheasant Run, Ponte Vedra Beach, Florida 32082.
