ARTICLES OF INCORPORATION

OF

Nob Hill Voice Over Productions, Inc

ARTICLE I

Name and Duration

The name of the company is Nob Hill Voice Over Productions, Inc. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

ARTICLE II

Principal Office

The address of the principal office of the Corporation is 150 Alhambra Circle, Suite 1270, Coral Gables FL 33134

ARTICLE III

Registered Office and Agent

The address of the registered office in the State of Florida is 150 Alhambra Circle Suite 1270, Coral Gables, FL 33134. The name of the registered agent at such address is James P. Gagel.

Corporate Purposes, Powers and Rights

1. The nature of the business to be conducted or promoted and the purposes of the Corporation are to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

ARTICLE VIII

The power to adopt, amend or repeal bylaws for the management of this Corporation shall be vested in the Board of Directors or the shareholders, but the Board of Directors may not amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that such bylaw is not subject to amendment or repeal by the Board of Directors.


