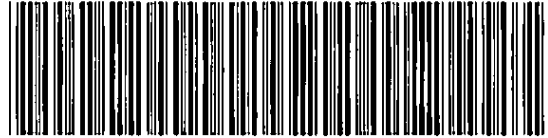

ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
CONNECTYX TECHNOLOGIES HOLDINGS GROUP, INC.

The undersigned, being the Chief Executive Officer and Director of Connectyx Technologies Holdings Group, Inc., a Florida corporation (the "Corporation"), hereby certifies that the following amendment ("Amendment") to the Corporation's Articles of Incorporation has been adopted by the applicable number of Shareholders and the Board of Directors of the Corporation via unanimous written action without a meeting on **November 11, 2020** with each director of the Company waiving notice of the meeting.

1. Pursuant to the provisions of Section 607.1006 of the Florida Statutes, Connectyx Technologies Holdings Group, Inc., a Florida corporation, does hereby amend its Articles of Incorporation.
2. The name of the corporation whose Articles of Incorporation are being amended by these Articles of Amendment is Connectyx Technologies Holdings Group, Inc., a Florida corporation.
3. Capitalized terms used herein but not otherwise defined shall have the meanings ascribed to them in the Articles of Incorporation of the Corporation, as amended.
4. After the filing and effectiveness pursuant to the Florida Business Corporations Act of these Articles of Amendment the Articles of Incorporation of the Corporation, at 12:01 am on November 30, 2020 (the "Effective Time"), the Corporation's Articles of Incorporation are hereby amended to read as follows:

"ARTICLE I

NAME

The name of this Corporation shall be **CURATIVE BIOTECHNOLOGY, INC.**"

5. This Amendment was duly adopted by the Board of Directors of the Corporation on November 11, 2020 and was duly adopted by the requisite Shareholders of the Corporation on November 11, 2020. The number of votes cast for the amendment by the Shareholders was sufficient for approval.

Including as set forth herein and in all other aspects, the Articles of Incorporation of the Corporation shall remain as they were prior to this Amendment being adopted.
