ARTICLE I - NAME

The name of this Corporation is Stonebridge Promenade Shops Springing Member I, Inc.

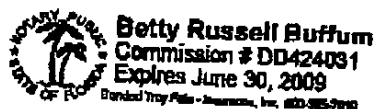
