#### **ARTICLES OF INCORPORATION**

THE UNDERSIGNED, for the purpose of forming a corporation under Chapter 621 of the Florida Statutes and the Florida Professional Service Corporation and Limited Liability Companies Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I

#### Name

The name of this corporation is VINNY M. VARGHESE, M.D., P.A..

# **ARTICLE II**

Duration

The term of existence of this corporation is perpetual.

#### **ARTICLE III**

## Purpose

The purpose for which the corporation is organized is to engage in the practice of the profession of medicine. The corporation may transact any and all business for which corporations may lawfully be incorporated under the Florida Professional Services Corporation and Limited Liability Companies Act, Chapter 621, Florida Statutes (2007), as amended.

#### ARTICLE IV
