ARTICLES OF INCORPORATION **OF** POUND FLY, INC.

The undersigned, acting as incorporator of the captioned corporation under the Florid Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I CORPORATE NAME AND PRINCIPAL OFFICE

The name of this corporation is POUND FLY, INC. (the "Corporation") and its principal office is 220 S. Franklin Street, Tampa, Florida 33602.

ARTICLE II **COMMENCEMENT OF CORPORATE EXISTENCE**

The Corporation shall commence its existence upon the filing of these Articles of Incorporation with the Florida Secretary of State.

ARTICLE IV CAPITAL STOCK

The aggregate number of shares of stock authorized to be issued by this corporation shall be 10,000 shares of common stock, each with a par value of \$.001.
