The undersigned hereby makes and subscribes to these Articles of Incorporation
intending to form a corporation under the provisions of the Florida Statutes.

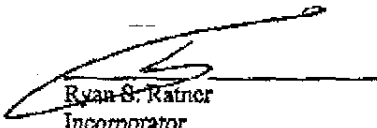
ARTICLE XI
