ARTICLES OF INCORPORATION

ARTICLE I
NAME AND ADDRESS

BUSINESS, OBJECTS OR PURPOSE

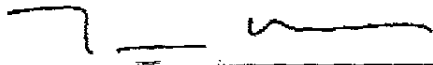
