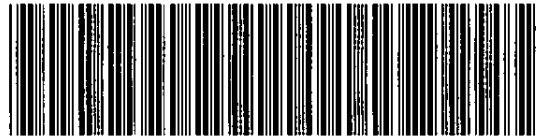



This Amendment shall be effective upon the filing of these Articles of Amendment by the State of Florida, Department of State.


